## **CNSC to conduct a hearing in writing on Ontario Power Generation's proposed consolidated financial guarantee**

The [Canadian Nuclear Safety Commission](#) (CNSC) will conduct a hearing based on written submissions in September 2022. The hearing is to consider whether to accept the consolidated financial guarantee proposed by Ontario Power Generation (OPG). The following OPG facilities are included in the consolidated financial guarantee:

- Darlington Nuclear Generating Station
- Pickering A and B Nuclear Generating Stations
- Bruce A and B Nuclear Generating Stations
- Western Waste Management Facility
- Pickering Waste Management Facility
- Darlington Waste Management Facility
- Radioactive Waste Operations Site 1

OPG's facilities are located on different sites in Ontario and in the traditional and treaty territories of many Indigenous Nations and communities. The proposed financial guarantee would assure funding for the future decommissioning associated with those sites.

Pursuant to rule 3 of the [Canadian Nuclear Safety Commission Rules of Procedure](#) (the Rules), the Commission has decided to vary the Rules in order to ensure that this hearing is dealt with as informally and expeditiously as the circumstances and the considerations of fairness permit. The Commission will consider written submissions from OPG and CNSC staff, as well as written interventions from members of the public.

The [hearing submissions](#) from OPG and CNSC staff will be available on the CNSC website at [nuclearsafety.gc.ca](http://nuclearsafety.gc.ca) or on request to the Commission Registry after **August 19, 2022**.

Pursuant to rule 19 of the Rules, persons who have an interest or expertise in this matter or information that may be useful to the Commission in coming to a decision are invited to comment, in writing, on OPG's proposed financial guarantee. Requests to intervene must be filed with the Commission Registry by **September 19, 2022**, using the [online request form](#), [email](#) or the contact information below. **The request to intervene must include the following information:**

- a written submission of the comments to be presented to the Commission
- the requester's name, address, telephone number and email address

All submissions will be available for download on the CNSC website or upon request to the Commission Registry. Personal information, such as address and telephone number, is essential for linking the submission to its author. If you wish to ensure the confidentiality of your personal information, please submit it on a separate page.

Following the deliberations and decision of the Commission on this matter, a record of decision will be published on the CNSC website at [nuclearsafety.gc.ca](http://nuclearsafety.gc.ca) and made available on request. A decision from the Commission is anticipated in fall 2022.
